1) The title, aims and description

The title „**DIGITAL TRANSFORMATIONS AND MULTICENTRIC LEGAL SYSTEMS**”

The program includes 75 hours of student work carried out in the form of:

1. A component of classes conducted remotely.
2. Component of classes carried out at Cracow University of Economics in Poland.
3. Students' own work.
4. Evaluation.

Virtual part of BIP- 7-10 July 2025

During offline activities in Cracow (point 2) of 15 hours on 12-16th July 2025 students will focus on the following topics: historical foundations and development of models of private law within various types of legal systems. Functioning of various legal systems in the sphere of digital relations, in particular Artificial Intelligence, Internet, online platforms, e-commerce, digital private law and human rights. During the course students will discuss among others, if Artificial Intelligence and other digital solutions influence the practice of law in EU in comparative perspective and how legal systems of various countries are coordinated in digital cases. Another aspect that is to be discussed is the future of law in digital reality, in particular in the field of decision-making and the work of the lawyer.

The methods used during the offline course are: lectures, case study, discussion, preparation of project and its presentation. Evaluation of both virtual and offline part will occur at the last day of the stationary of the BIP.

2) METHODS AND OUTCOMES

The course will be implemented partly virtually and partly face to-face. The preliminary virtual phase (**7-10 July 2025**):

- 10 hours
- comparative and historical analysis of law as well as EU private international law. The analysis focuses of legal norms applicable in digital state of facts, in particular Artificial Intelligence and Internet. The methods used during the online course are: lectures, case study and discussion.

Face-to-face phase (12-16 July 2025):

- 75 hours in total

Evaluation of both virtual and offline part will occur at the last day of the stationary of the BIP

3) THE LEVEL OF STUDIES – TARGET GROUP

Students of the 1st and 2nd cycles (bachelor and master) of study are eligible to take the course. The minimum English language level requirement is B2.

4) DATE OF THE BEGINNING: 7 July 2025

5) DATE OF END: 16 July 2025

6) PERIOD OF FACE-TO-FACE PART: 12-16 July 2025

7) VIRTUAL COMPONENT SCHEDULE:

The virtual component will be before the face-to-face part.

8) VIRTUAL COMPONENT PERIOD: 7-10 July 2025

9) DESCRIPTION OF THE VIRTUAL COMPONENT

During online activities of 10 hours between 7th and 10th July 2025 students will participate in virtual classes. The digital part introduces students to the stationary part of the course. The digital course is focused on comparative and historical analysis of law as well as EU private international law. The analysis focuses of legal norms applicable in digital state of facts, in particular Artificial Intelligence and Internet. The methods used during the online course are: lectures, case study and discussion. Evaluation of the virtual part will occur with the stationary part at the end of the BIP.
