Organised in hybrid format by the University of Salerno and Transilvania University of Brasov, this one-day conference invites academics to engage in critical and interdisciplinary dialogue on both the potential and the limitations of current legal frameworks.

Submission Guidelines

We welcome proposals from national and international experts in the topic covered, both from the academic world and specialized institutions and organizations, as well as early career researchers and PhD candidates.

Abstracts (maximum 350 words) should be submitted by 27 July 2025 and must include:

- Title of the paper,
- Author's name, affiliation, and email,
- Up to five keywords.

When submitting your abstract, please also include in your email:

- A short bio (maximum 100 words),
- An indication of whether you would like to present your paper in person or online.
